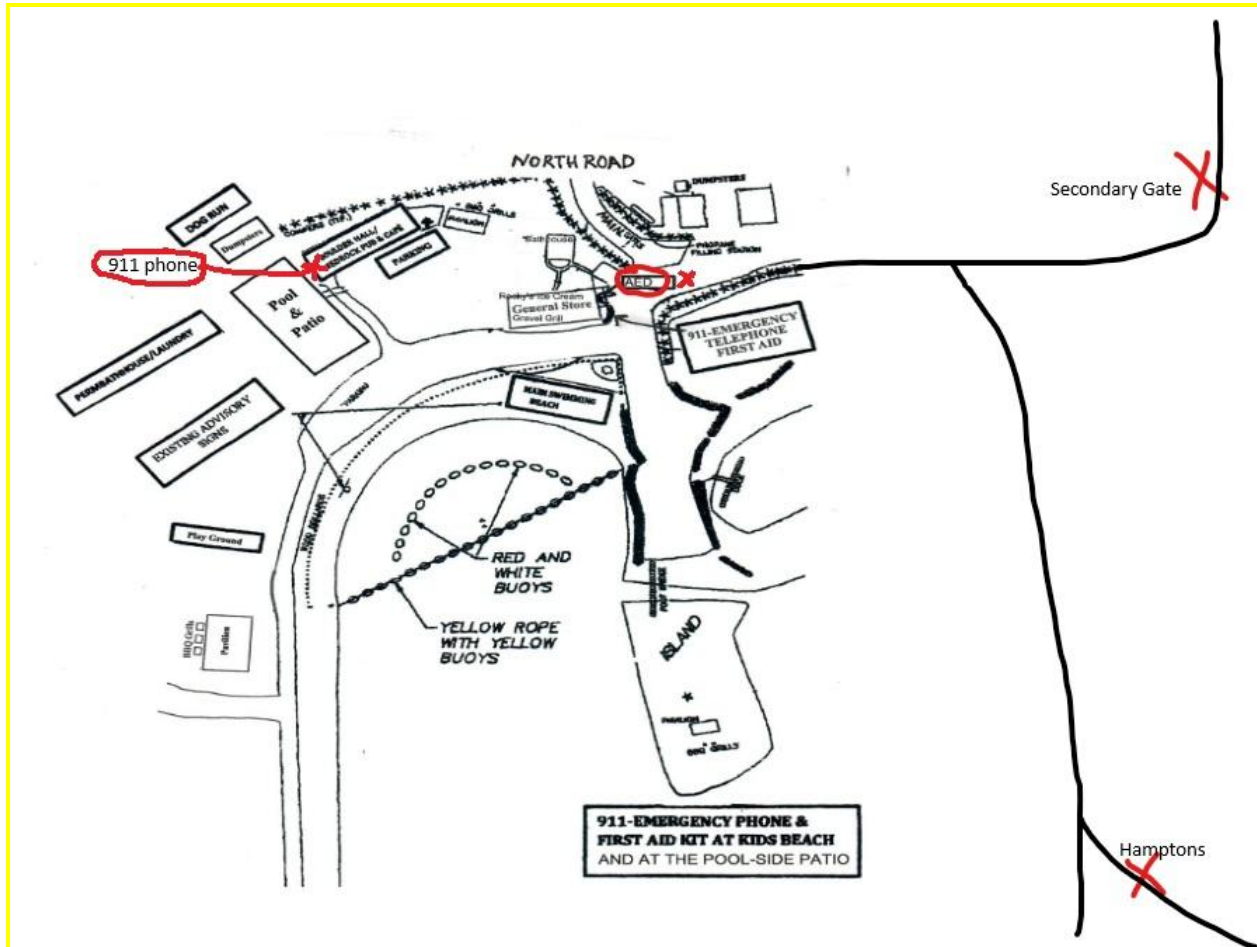

2. *A REGULAR MEMBER MUST BE AT LEAST 18 YEARS OLD.*
3. ADDING OR CHANGING A SECONDARY MEMBER ON A REGULAR MEMBERSHIP APPLICATION WILL RESULT IN A \$50 FEE. THE CHANGE WILL NOT BE PROCESSED WITHOUT THE RETURN OF THE ORIGINAL GATE CARD AND THE GRAVEL PONDS LAMINATED ID CARD. **NO EXCEPTIONS!**
4. NO GATE CARDS, FOR ENTRANCE WILL BE TURNED ON UNTIL ALL FEES ARE PAID IN FULL. YOU MUST ALLOW 72 HOURS FOR PROCESSING OF PAYMENT.
5. NO MEMBERSHIP TRANSFERRING IS ALLOWED.
6. EACH MEMBER IS RESPONSIBLE FOR LEARNING THE LOCATION OF FIRST AID STATIONS, AED, PUBLIC 911 PHONES, BEACH SAFETY EQUIPMENT AND EMERGENCY EXITS.

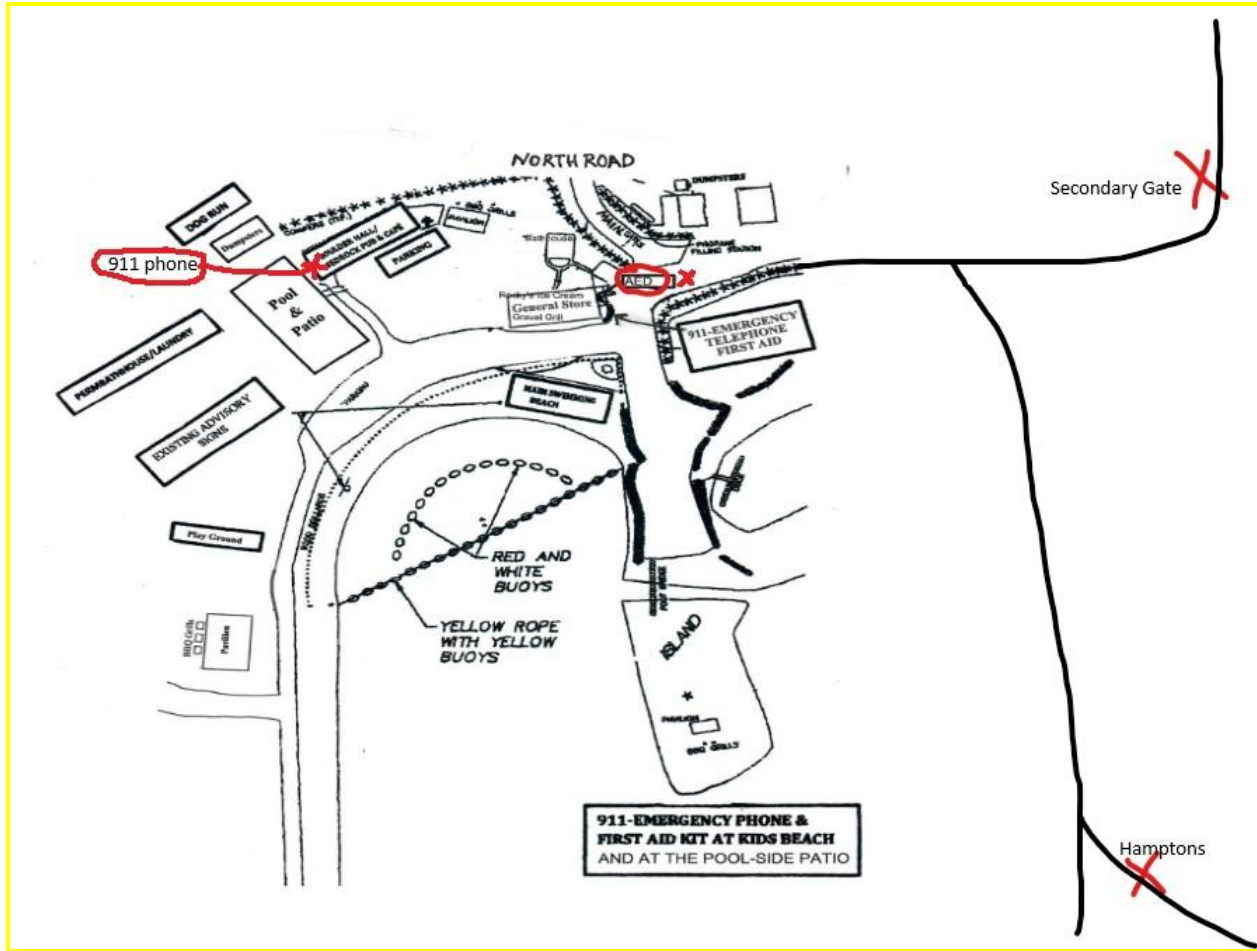


BEACH, POOL, & SPA INFORMATION

1. **NEVER SWIM ALONE!** *A minimum of two adults, 18 years of age or older must be present whenever the swimming facility is in use with*
 - **At least one adult remains on the dry sand, if at a beach.**
 - **At least one adult remains on the pool deck, if at the pool.**
2. **THERE IS NO SUBSTITUTE FOR ADEQUATE SUPERVISION.** *Children ages 16 and under must be accompanied to the bathing facility (beaches and pool area) by a parent or guardian.*
3. **IN AN EMERGENCY, NOTIFY THE GENERAL STORE (THEY WILL NOTIFY MANAGEMENT PERSONNEL) AND CONTACT HELP AS SOON AS POSSIBLE. PHONE NUMBERS ARE POSTED BY THE EMERGENCY PHONE.** *A free telephone is provided at this facility (at the Main Beach #1: beside the first aid kit and AED box on the front of the store wall, across from the main beach. Kiddie Beach #2: on the side of the gray building on beach front. Pool and Spa: attached to the side of the Boulder Hall building, across from the gate entrance. **THERE IS AN EMERGENCY ALARM BUTTON LOCATED AT EACH LOCATION. PUSH THE RED BUTTON AND AN ALARM WILL SOUND.***
4. **ONLY USE THE BEACH/POOL/SPA FACILITY DURING THE POSTED HOURS OF OPERATION.**
5. **NO ONE UNDER THE AGE OF 18 YEARS OLD IS ALLOWED IN THE SPA AT ANY GIVEN TIME.**
6. **SWIM ONLY IN THE DESIGNATED BATHING AREA OF THE BEACH. DO NOT PASS THE BUOY'S.**
7. **THE POOL AND SPA HAVE SHALLOW WATER-THERE IS NO DIVING ALLOWED.**
8. **DON'T DRINK ALCOHOL AND SWIM.**
9. **AT ALL TIMES, YOU MUST FOLLOW ALL OTHER RULES AND REGULATIONS THAT ARE POSTED, INCLUDING BUT NOT LIMITED TO, NO DRINKS OR FOOD OF ANY KIND IN THE POOL OR SPA AREA.**
